#### Capacity building on effective engagement of different stakeholders in NDC implementation -Experiences from Southeast Asia-

### **Concept Note**

#### **Background:**

Developing country governments are in efforts to accelerate the implementation of their nationally determined contributions (NDC). With recent updates with higher ambitious target in 2030, together with Net Zero Emission goal as their long-term strategies (LTS), there are growing interests to scale up climate action through engagement of different stakeholders, such as the private sector, local governments, academia, non-government organizations, citizens, etc.

As the role of the national government may be defined as giving the oversight and facilitate climate actions in respective stakeholders, capacity-building of governments to effectively engage stakeholder is crucial. In turn, capacity-building of stakeholders toward the implementation of NDC is also important, as their contribution can affect the success of the scenario of mitigation and adaptation efforts.

#### **Objectives:**

The objective of the session will introduce views and knowledge regarding ways to promote effective stakeholders engagement in NDC implementation, through capacity building activities. In particular, the session will invite panelists who are engaged in capacity-building practices from government, bilateral and multilateral development cooperation agencies, etc. Also, the case studies will be shared from the experiences of Southeast Asian countries, such as Viet Nam, Thailand and the Philippines.
