1. Background

The Intergovernmental Panel on Climate Change (IPCC) 6th Assessment Report (AR6) highlights a solution framework called Climate Resilient Development (CRD), which is a process of implementing greenhouse gas mitigation and adaptation options to support sustainable development for all in ways that support human and planetary health and well-being, equity, and justice. The same report also highlighted the importance for countries around the world to step up their efforts to achieve the objectives of the Paris Agreement.

Furthermore, the 2023 Global Sustainable Development Report showed that among the 36 targets reviewed, only two are on track to be achieved, while poverty eradication, gender equality, education and eliminating hunger has suffered significant setbacks cause by conflicts, pandemic crisis, climate related disasters and more.

As a way forward to achieve the Paris Agreement and the Sustainable Development Goals (SDGs), a holistic approach such as CRD that consider the interlinkages between SDGs, minimize trade-offs and maximize synergies, and address medium-and long-term objectives while dealing with immediate crises must be taken.

JICA formulated a Global Agenda for Climate Change (JGA) (June 2021) which has at its core to promote the implementation of the Paris Agreement and the co-benefit approach to promote climate change countermeasures in development projects with concrete targets.

With the CRD in mind JICA redefined it's "co-benefits of climate change" approach as measures to realize CRD. To achieve this, adaptation and mitigation measures are considered the main pillars to minimize the climate change risks, and at the same time pursuing maximum consideration to the natural environment, biodiversity, etc., in order to maximize synergies and minimize potential trade-offs with other SDGs.

2. Objectives

The main objective of this side event is to bring together key stakeholders to foster dialogue, share knowledge, discuss about holistic approaches and future challenges in promoting CRD, explore solutions to the challenges posed by climate change, while also examining the interlinkages of climate actions and SDGs.
